# BASIC TERMS AND CONDITIONS

- 1. Booth Information:** Booth reservations must be made in advance of *Run With The FUZZ*.
- 2. Liability:** *Run With The FUZZ* (sponsored by *05 Events*) will provide security throughout the entire event from initial set-up to final tear down. *Run With The FUZZ* will not be liable to the exhibitor, his employees, agents, or guests for any damage, loss, or injury from fire, electricity, water, storm, riot, smoke, theft, or any other cause.
- 3. Use of vendor information and name:** Exhibitor gives *Run With The FUZZ* and *05 Events, Inc.* the right to use its name in *Run With The FUZZ* advertising, websites, and promotional material. Namely: *05 Events, Inc.* will place exhibitor's logo and possibly company information on event website, flyers, promotional material, and t-shirts. Vendor's name and description may be discussed via PA at event. Request for approval from Exhibitor will be made by sponsor prior to printing of promotional material or online listing of website.
- 4. Display times:** All displays must remain completely setup for all hours of the show, up to and including 1pm. Early teardown is NOT allowed.
- 5. Set-up times:** All exhibitors must be set-up and ready for business at the start of dog walk (9 am).
- 6. Promotional/sale products:** All products and services to be sold must be listed in writing on an attached sheet that is subject to final approval by *Run With The FUZZ*. *Run With The FUZZ* and *05 Events, Inc.* reserves the right to stop any sales of products not approved on the list with this contract. Failure to cease in sales of unapproved products or services will subject exhibitor to immediate removal from the show.
- 7. Permission to roam at event:** Vendor will be permitted to roam freely about event with products & promotional material in order to promote organization and speak with attendees.
- 8. Litigation:** It is agreed that any litigation regarding this contract shall be litigated in the appropriate Court in the State of Colorado.
- 9. Participation:** Participation in *Run With The FUZZ* is subject to final approval by *Run With The FUZZ* sponsor (*05 Events, Inc.*). Subletting or sharing of space in any form is prohibited unless explicitly written and signed by an authorized *Run With The FUZZ* representative.

10. **Responsibilities:** The responsibilities of *Run With The FUZZ* and *05 Events, Inc.* are limited to those listed within this contract. *Run With The FUZZ* and *05 Events, Inc.* shall not be held liable for any promises made by any of its representatives in the event of non-participation or no-show; in which case this contract becomes the sole responsibility of the signer.

12. **Provisions:** *05 Events, Inc.* will provide Exhibitor with table, 2 chairs, and tent coverage, as well as free beverages and small food items from additional sponsors. The cost for this provision is \$200. If vendor wishes to provide his/her own material, the cost is \$100. Signage and organization promotional material will be the sole responsibility of the exhibitor.

13. **Release:** I hereby hold harmless and indemnify the Dumb Friends League, Wag `n Trail organizers, volunteers, underwriters, sponsors, employees, as well as the owner of the area where the event is held and the owners of any Wag `n Trail related property for any action relating to the Wag `n Trail, including theft, damage or injury. I agree to pay any reasonable attorney fees and costs incurred by the Wag `n Trail or its organizers as a result of actions by me that are covered by this agreement.
